# Privacy Policy

DG TAKANO Co. Ltd. ("us", "we", or "our") operates the <https://meliordesign.com/> website (hereinafter referred to as the "Website").

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Website and the choices you have, associated with that data. We use your data to provide and improve the Website. By using the Website, you shall be deemed to have agreed to our collection and use of information in accordance with this policy. If you do not agree to the terms of this Privacy Policy, please do not use the Website.

## Definitions

### Website

Website is the <https://meliordesign.com/> website operated by DG TAKANO Co. Ltd.

### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

### Usage Data

Usage Data is data collected automatically either generated by the use of the Website or from the Website infrastructure itself (for example, the duration of a page visit).

### Cookies

Cookies are information stored on the terminal (computer or mobile device) of the user using the Website (terminal identifier).

## Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Website to you.

## Types of Data Collected

### Personal Data

We may receive and store Personal Data that you send us through our website, or give us by any other way. Personal Data can be used to contact or identify you. Personal Data may include, but is not limited to:

- Email address
- First name and last name
- Address, State, Province, ZIP/Postal code, City

## Usage Data

We may also collect Usage Data on how the Website is accessed and used. This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), Operating System (OS), browser type, browser version, the pages of our Website that you visit, your access location, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

## Tracking Cookies Data

We use cookies and similar tracking technologies to track the activity on our Website and we hold certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyse our Website. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Website.

Examples of Cookies we use:

- **Session Cookies.** We use Session Cookies to operate our Website.
- **Preference Cookies.** We use Preference Cookies to remember your preferences and various settings.
- **Security Cookies.** We use Security Cookies for security purposes.

## Use of Data

DG TAKANO Co. Ltd. uses the collected data for the following purposes:

- To provide and maintain our Website
- To notify you about changes to our Website
- To provide customer support
- To gather analysis or valuable information so that we can improve our Website
- To monitor the usage of our Website
- To detect, prevent and address technical issues

## Transfer of Data

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction. If you are located outside Japan and choose to provide information to us, please note that we transfer the data, including Personal Data, to Japan and process it there. Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

DG TAKANO Co. Ltd. will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

## Disclosure of Data

### Legal Requirements
